# Planning Board Meeting Saturday, June 13, 2009 Frye Island Community Center

Steve Kaplan, chairman, called the meeting to order at 8:35 a.m. The chairman appointed alternate Marge Hommel as a voting member for the meeting.

## **Minutes and Correspondence**

Ed made a motion to approve the 5/23/09 minutes; seconded by Dave Treacy with all in favor.

#### **Old Business**

### Go over new dock regulation of Raymond, Windham, Casco and Naples

Steve asked Ed Johnson for an update on the dock regulations for the surrounding waterfront communities. Ed spent a lot of time researching information on the web and stated all the towns are working on updating the dock portion of their Shoreland Zoning Ordinance. Ed passed out Raymond's, Casco's and Naples changes and stated that Windham had opted out.

Casco stated the changes are proposed, but hadn't yet been voted on. After reviewing each one, Steve stated he liked Casco's which are exactly the same as the State's guidelines. Raymond and Naples made changes to be more in compliance with the State. Steve asked if there was any discussion or objections regarding the Casco proposal for the dock guidelines. Ed Johnson was opposed and stated why.

#### **New Business**

### Update Shoreland Zoning for submission to the State of Maine for approval

After a lengthy discussion regarding the pros and cons for the various communities' proposals, Steve asked for a motion to accept page 17 of the Department of Environmental Protection Chapter 1000: Guidelines for Municipal Shoreland Zoning Ordinances

Marge Hommel moved to add the dock provisions to our current Shoreland Zoning Ordinance as proposed by the State; seconded by Dave Treacy; carried by a 3 to 1 vote with Ed Johnson opposed.

This will need to be presented at a public hearing which will be at our next meeting and then voted on at the next Town Meeting. Marge felt the CEO should be present at the Public Hearing. Steve said he would check with him to see if he could be available for our June 27, 2009 meeting.

Marge stated the DEP is very restrictive so she would be comfortable letting the chairman use his discretion. Some felt it could place the chairman in a compromising position. After discussing alternatives, the board was comfortable having the chairman do either a phone or e-mail consultation with the board members. Three "YES" votes would be required to carry the approval.
